

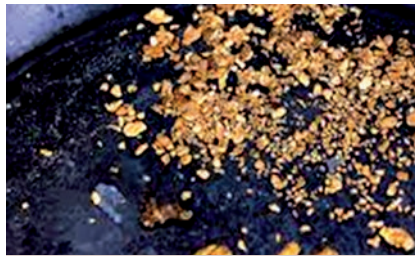

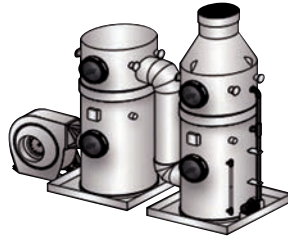

## Example of a usual issue arising in **light chemicals**

- Treatment of gas on reactors (HCl, SO<sub>2</sub>, etc.)
- Scrubber or safety scrubber (F, Br<sub>2</sub>, Cl<sub>2</sub>, NH<sub>3</sub>)
- Pollutants: CN, HF, HNO<sub>3</sub>, Cl<sub>2</sub>, HCl, SO<sub>2</sub>, NH<sub>3</sub>, VOC, etc.

- Pollutant: NMP between 7 & 9 mg/m<sup>3</sup>
- Airflow: 24 500 m<sup>3</sup>/h at 32°C

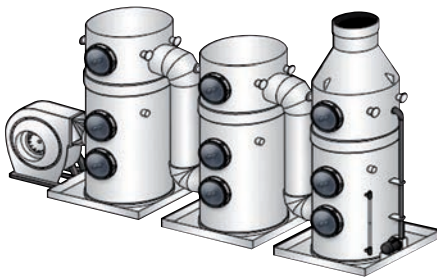

- Pollutants: CN, HF, H<sub>2</sub>S, NH<sub>3</sub>, Cl<sub>2</sub>, SO<sub>2</sub>, HNO<sub>3</sub>, etc.
